Caring For Our Communities! The Volunteer Lawyers Service

If you have not yet heard, the Volunteer Lawyers Service (VLS) is a program that has been providing eligible non-partisan charitable organizations with pro bono legal services for over ten years. The success of this program is a result of our dedicated volunteer lawyers who donate as much time as they are able, to assist not for profit groups throughout Alberta. The legal services our volunteers provide to these organizations increases access to justice and legal aid that would otherwise be unavailable because of a lack of financial resources. Mary Anne Wilkat, of Ogden House Seniors Centre commented, "It has been wonderful to know that this opportunity to have access to a volunteer lawyer is available, especially because we are a non-profit organization with no money..." and Sandra Hebert from the Calgary Winter Festival Foundation agrees; "We knew we needed to re-organize our program in order to move forward with our expansion plans, and this would not have been possible without the VLS because we would not otherwise have had the funds to seek the advice we required"

The not-for-profit organizations who seek the services of our volunteers are groups that provide numerous benefits to our communities. Whether they are just starting out, or are in the process of expanding, our lawyers are catalysts for their development, growth and even sometimes their sustainability. For instance, the Medicine Hat Youth Action Society, is a not-for-profit group that helps at-risk youth, but because of a contentious legal issue, they themselves had become "at risk" for closing their doors. With the assistance of one of our volunteer lawyers, this group was able to resolve their matter and remain open. The VLS has also hosted an annual workshop which was facilitated by one of our volunteer lawyers who provided "start up" information and services to three newly developed not-for-profit organizations looking for direction in becoming operational. By offering their time to these groups, volunteer lawyers are by extension écaring for our communities.
